- 1.) All classes will begin promptly. The class instructor(s) will not delay the start of any class for any individual participant.
- 2.) All participants agree and acknowledge that the dog/puppy that they own/are attending class with is non-aggressive (to both other dogs and to people) and is fully housebroken. Participants are required to clean up after their dog, both inside and outside of the training facility. Failure to clean up after your dog will result in a permanent bar from attending any future training sessions.
- 3.) All participants agree and acknowledge that they will not bring any in season bitch to any class or on the premises.
- 4.) All participants agree and acknowledge that they will provide Carroll Kennel Club, Inc., a copy of the above named dog's rabies vaccination record for attachment to this form, prior to participating in any class.
- 5.) All participants agree and acknowledge that the above-named dog meets the following age requirements:

**Handling Class:** 4 months minimum

**Agility Class:** Between one (1) and five (5) years of age.

By your signature below, the undersigned participant/handler hereby understands, acknowledges and agrees that they shall indemnify and hold Carroll Kennel Club, Inc., Carroll Indoor Sports Center or The Carroll Agriculture Center, and their respective agents and representatives, harmless from any claim for damage to themselves, the above-named dog, any property, other person(s) or other dog(s), while the undersigned is a participant in any training class sponsored by Carroll Kennel Club, Inc. The undersigned also hereby accepts all liability and responsibility for the acts of the above-named dog; to include any damage caused by said dog to any persons(s), property, or other dog(s).
